The Halaal Slaughterer is responsible for performing slaughtering procedures on chickens in a manner that aligns with the Islamic guidelines, ensuring that all slaughtering tasks and/or processes conducted adhere to the Halaal laws and ethical standards. The role involves precision, expertise, and a deep understanding of the religious requirements related to animal slaughter, as well as maintaining hygiene, safety, and humane treatment throughout the process.

KEY FUNCTIONS AND RESPONSIBILITIES

Slaughtering

- Inspect and verify that the equipment used for slaughtering is properly cleaned and sterilized.
- Maintain cleanliness and hygiene in the slaughtering area to ensure the sanctity of the process.
- Perform Halaal slaughtering of poultry in compliance with Islamic principles and practices.
- Ensure that each slaughtering process is executed accurately and in line with Halaal requirements.
- Severing jugular veins of stunned animals to drain blood and facilitate dressing
- Operating restrainer and stunning equipment
- Maintenance of the cutting equipment (knives, cutters, and other elements).
- Ensure all birds are slaughtered as per Namib Poulrty and Halaal standards.
- Perform Halaal slaughtering of poultry in compliance with Islamic principles and practices.
- Ensure that each slaughtering process is executed accurately and in line with Halaal requirements.

Housekeeping

- Participate in maintaining a clean, organized, and safe working environment.
- Perform routine cleaning and sanitization tasks in the processing plant.
- Dispose of waste and by-products in accordance with company procedures.
- Keep work areas clean and free from potential hazards.
- Report any maintenance or housekeeping issues promptly to the relevant supervisor/ manager.

General

- Ensure prompt Time and Attendance
- Adhere to safety regulations and guidelines to prevent accidents and ensure the well-being of yourself and others.
- Employ food safety procedures based on Good Manufacturing Practices (GMP)

- Carry out ad hoc tasks as given by the superior and/or management.
